Santa will arrive at Skate Frederick in unique fashion to have breakfast, skate, and have FUN!!!

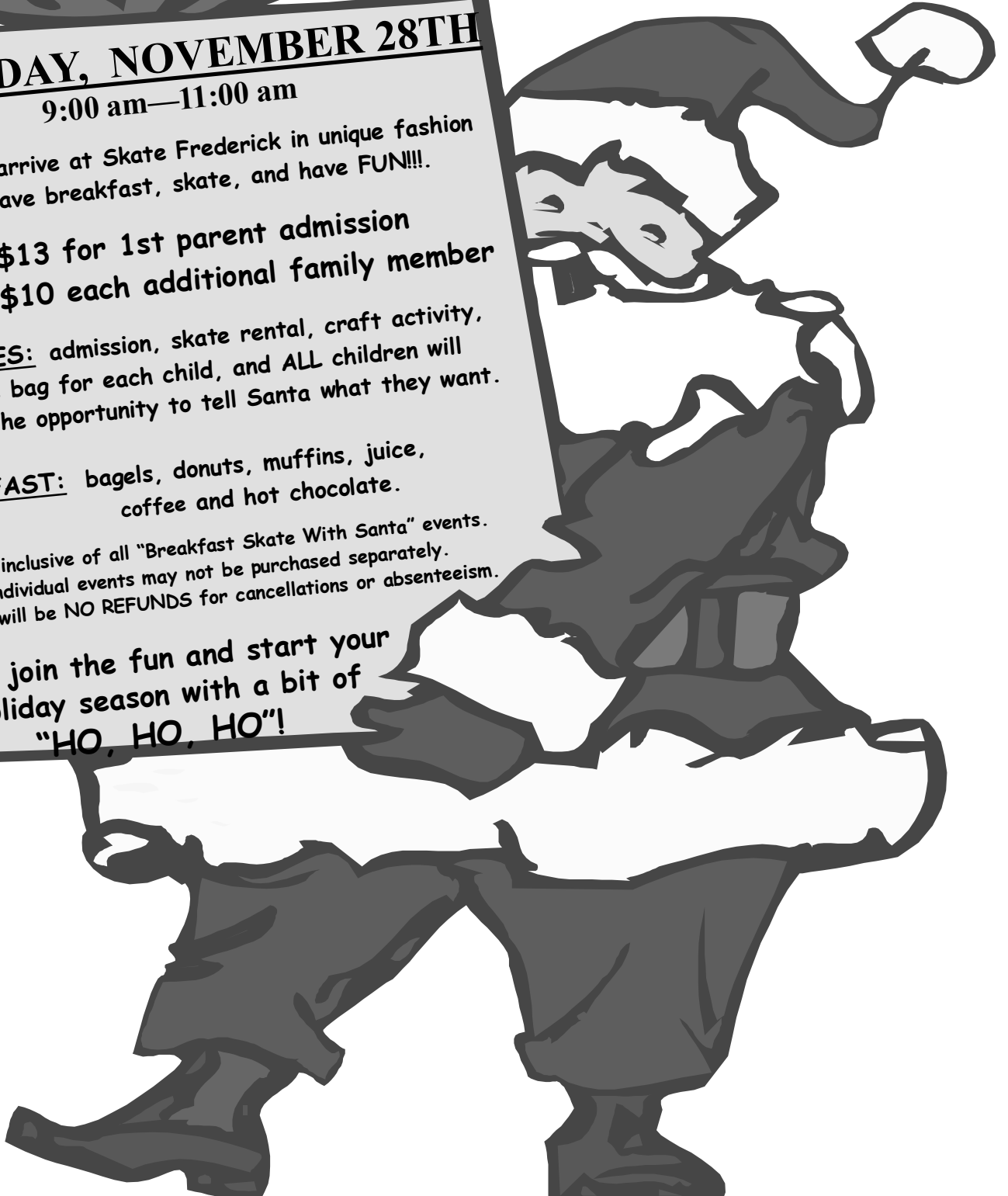
COST: \$13 for 1st parent admission
